These rights are the pillars of the protection of the intangible assets which are the main drivers of the economic activity and innovation in different industries.⁵

Additionally, the name of a construction project should also be registered as a trademark to maintain exclusivity and prevent identity crises. Failure to enforce trademark rights can result in loss of the first mover advantage and jeopardize the project's unique identity and market positioning. Trademarks extend beyond tradenames to include any brands or logos associated with construction projects undertaken by a reputable firm. A notable example is the naming of large residential or commercial projects, where failure to secure trademark registrations can lead to identity crises and market confusion. Without proactive enforcement of trademarks, competitors may exploit the project's reputation and launch similar-named projects, diluting the original brand's value and market exclusivity. For instance, iconic structures such as the Taj Hotel building, owned by IHCL, have been trademarked to protect their unique architectural features and iconic value. Similarly, in 2018, the BSE obtained trademark registration for its Phiroze Jeejeebhoy Towers, safeguarding the distinctiveness of the structure and its associated brand identity. To mitigate the risk of trademark infringement and protect their intellectual property (IP) assets, construction firms must prioritize awareness and proactive enforcement of trademark

By securing trademark registrations for tradenames, brands, and trade dress associated with construction projects, firms can safeguard their stake and maintain exclusivity in the market.

- **Patent** In the realm of the construction industry, patents serve as a cornerstone for protecting novel inventions and technological advancements that drive innovation and competitive advantage. As construction firms increasingly leverage new technologies and equipment to enhance efficiency and quality, securing patents becomes essential to safeguarding their intellectual property and retaining a strategic edge in the market. Patents are designed to protect unique and novel inventions that meet specific criteria, including novelty, non-obviousness to a person skilled in the art, and industrial applicability. In the context of construction, innovation plays a pivotal role in shaping the success and competitiveness of firms. Construction entities are continuously exploring novel methods, technologies, and machinery to improve construction processes, enhance safety standards, and optimize resource utilization. One notable area of innovation in the construction industry is the development of automatic construction devices, which streamline construction processes and increase efficiency. These devices, such as those described in patent application IN202211002180, leverage automation and advanced technologies to expedite construction activities, minimize errors, and reduce labour costs. Methods and processes for economical building construction represent another area of focus for patent protection in the construction sector. Patent application IN202211000870 exemplifies innovative approaches to cost-effective construction techniques, which enable firms to deliver high-quality structures while minimizing construction costs and maximizing resource efficiency. The integration of artificial intelligence (AI) and machine vision technology into construction safety management systems represents a significant advancement in ensuring workplace safety and risk mitigation. Patent application IN202221000836 demonstrates the application of AI-based solutions to enhance safety protocols, monitor construction sites in real-time, and identify potential hazards proactively. Research and development efforts within construction businesses span

These innovations contribute to improving the efficiency, durability, and sustainability of construction projects, thereby enhancing the overall quality of built environments. Innovations originating from Indian construction firms have the potential to transform industry practices and set new standards for excellence. By securing patents for their inventions, construction firms can protect their investment in research and development, deter competitors from replicating their innovations, and capitalize on their technological advancements.

- **Architectural copyrights** Architectural copyrights serve as a vital form of intellectual property protection for architects, safeguarding their original and innovative works from unauthorized use or reproduction. Under this legal framework, architects enjoy exclusive rights over their creations, including architectural designs, blueprints, Building Information Modeling (BIM), design documents, adaptations, elevations, and even the structures themselves, provided they meet the criteria of uniqueness, creativity, and tangibility. The Berne Convention, a global treaty aimed at safeguarding creators' rights to creative and literary works, has recognized architecture as a 'protected work' over time. With India being one of the 177 current members of this pact, architects in the country benefit from the international recognition and legal framework established by the Convention to protect their intellectual property rights. In India, architectural designs and personalities are protected by copyright under Section 13 of the Copyright Act. This provision grants architects exclusive rights over their designs, structures, and drawings, allowing them to prevent unauthorized copying or reproduction of their works. However, it's important to note that copyright protection does not extend to the underlying engineering and construction techniques used in the creation process. A significant legal precedent in the protection of architectural copyrights was set in the case of *Raj Rewal v. Union of India*¹⁰. In this landmark case, the court demonstrated empathy towards the architect, recognizing the sentiment and respect due to the creator and their work. This case underscored the importance of acknowledging and protecting the creative and intellectual contributions of architects in the built environment.

Section 57 of the Copyright Act grants moral rights to architects, allowing them to assert ownership over their creations and prevent any unauthorized alterations or modifications. Architects have the right to seek injunctions to restrain violators from using their works, thereby preserving the integrity and originality of their designs. Architects may face limitations in seeking remedies under copyright law once construction of a building or structure is completed. Section 59 of the Copyright Act stipulates that architects may not be eligible for certain remedies after construction has concluded. In such cases, architects may pursue damages lawsuits or criminal charges against infringers to seek redress for any violations of their rights.¹¹To further strengthen their protection, architects have the option to register their original creations through the Copyright Registration System. Although registration is not mandatory in India, it is advisable as it provides architects with a stronger legal defence in the event of copyright infringement. By registering their architectural designs, architects can assert their rights more effectively and safeguard their creative works against unauthorized use or reproduction.

- **Designs** In the construction industry, intellectual property protection extends beyond copyrights and patents to include design rights, which play a crucial role in safeguarding the aesthetic aspects of architectural works and innovative product designs. The Designs Act, 2000, along with the Designs Rules, 2001, provides a framework for the registration of architectural works under Class 25-03 and 25-99. However, there may be instances where it is unclear whether architectural works should be protected under the Designs Act or the Copyright Act. Unlike patents, which protect functional aspects of inventions, industrial design rights focus on the non-functional or aesthetic aspects of products. This includes elements such as shapes, textures, and ornamentation. Industrial design rights, akin to design patents in other jurisdictions, do not require the product to be novel; instead, only its aesthetics need to be unique to qualify for registration. For instance, in the construction industry, if an interior designer creates a unique design for a furniture piece or a decorative element, they can register the design as intellectual property under industrial design rights. This allows them to protect the visual appearance of their creations from unauthorized copying or reproduction, even if the underlying technology or
